The committees work to develop standards with regional and international standards bodies in developing standards. The approval of requests for standards development is done by the Standards Management Committee (SMC). During the development of Uganda Standards, draft standards are circulated for discussion within the technical committees or sub-committees. These draft standards pass through a number of stages before being presented to NSC for approval as Uganda Standards.
